§ 3.

The amount provided for in § 2, constitutes the amount limit of the Guarantor's liability.

§ 4.

The Guarantor shall be liable under this guarantee within the period stipulated in § 2 and within six months from expiry of this period, i.e. until \_\_\_\_\_.

§ 5.

The Guarantor shall make payment upon the first written demand of the Beneficiary submitted within the period of the Guarantor's liability hereunder within the period of seven days from receipt of such demand. The letter of demand should be signed by persons duly authorised to undertake financial liabilities on behalf of the Beneficiary, as provided for in the copy of the bank specimen signature form, as attached to the letter of demand, and should contain the Beneficiary's statement to the effect that required amounts have become due and payable.

§ 6.

Each withdrawal under this guarantee appropriately reduces the Guarantor's liability under this guarantee.

§ 7.

The security shall be released immediately upon the request of the lottery organiser, after verification of the request in terms of no liabilities under the guarantee.

§ 8.

The rights resulting from this guarantee cannot be assigned.

§ 9.

For the matters unregulated in this guarantee the provisions of the Act of November 19 2009 on games of chance (Journal of Laws of 2016, item 471 as later amended), Act of April 23 1964 – Civil Code (Journal of Laws of 2017 item 459) and Act of August 29 1997 – Banking Law (Journal of Laws of 2016 item 1988) shall be applicable.

§ 10.

All disputes arising out of execution of the guarantee shall be settled by the court competent for the head office of the Beneficiary of the guarantee.
