#### 2016 SUBSTANTIVE REPORT

#### ON ACTIVITY OF

#### BANK MILLENNIUM FOUNDATION

On 10 December 1990 by virtue of a notarial act prepared in Notarial Office No. 24 in Warsaw (deed No. REP A3/3/90) a Foundation was established under the name then of "Closer to Europe". The decision approving the Foundation and articles of association was signed by the Minister of Finance. The Foundation was registered by the Regional Court for Warszawa Praga on 8 March 1991 (Ref. No. INS Ref. F-184/91) by means of entry in the Foundations register under the number RFI 1132.

In the period from 5 December 2011 to 25 August 2016 the Foundation was operating under the name "Life Inspires Us" Foundation. Under a Resolution of the Foundation's Supervisory Board and pursuant to a Decision of the Court of Registration of 25 August 2016 the Foundation is operating under the name of **BANK MILLENNIUM FOUNDATION**, which was confirmed by registration by the Regional Court for the Capital City of Warsaw, 12<sup>th</sup> Business Department of the National Court Register (file No. WA XII KRS 024976/16/879) under the number **KRS:** 0000097600.

The Foundation is headquartered in the Capital City of Warsaw, ul. Stanisława Żaryna 2A.

The Foundation does not engage in business activity.

The reporting period covers the period from 01.01.2016 to 31.12.2016

- financing, organising and creating a material base for training, leisure, treatment and therapeutic rehabilitation of employees of banking and financial institutions;

- supporting any and all initiatives to increase efficiency of Polish banking and financial institutions;
