

# Format description of VideoTEL (ESOBIG) Polish foreign payments file

#### 1 General information about VideoTEL (ESOBIG) Polish foreign payments file format

This document explains formats of VideoTEL / ESOBIG file - used to import / upload cross-border credit transfers or orders in foreign currency (other than PLN). Imported order are edited in New International / Foreign Currency Order form.

VideoTEL / ESOBIG file format is based on standard developed by ComputerLand, developer of VideoTEL / ESOBIG software.

### 2 General rules applying to VideoTEL (ESOBIG) file

- File does not contain header.
- One record (line) contains one separate order. Order records (lines) are separated with end of line character <CR><LF> (HEX 0D 0A)
- Fields are separated with space (HEX 20)
- If a field consists of more than one subfields (within one field) each subfield is delimited with ??? (tripple HEX 3F)
- Nearly all fields are within inverted commas " (HEX 22)
- If a field contains inverted comas " (HEX 22) it has to be replaced by " (double HEX 22)
- Account numbers of all orders have to be in database
- Code page Windows 1250 must be used
- One file may contain maximally 1000 orders
- Default extension of the file is \*.imp
