# SUBMISSION OF APPLYING FOR PFR SUBSIDY



# How to apply in Millenet for Companies?

## WHO MAY APPLY?

- The Financial Subsidy Agreement is signed by one person, acting on behalf of the Beneficiary Entrepreneur, duly authorised or entitled to represent the Entrepreneur to this extent.
- The Bank will verify the authorisation to represent the Entrepreneur in one person on the basis of data contained in the National Court Register (Krajowy Rejestr Sądowy) or Central Register and Information on Economic Activity (Centralna Ewidencja i Informacja o Działalności Gospodarczej).
- In the case of an attorney, the Bank will verify the correctness of the power of attorney and its content, which must conform to the standard established by PFR and contain qualified electronic signatures of the persons granting powers of attorney or in case of a written form their notarized signatures.
- You have time until 31.12.2020 to provide the power of attorney or statement on the confirmation of activities to the Bank. Failure to submit these documents will mean the need to return the subsidy.

## WHAT YOU SHOULD KNOW:

- The application must be started and finished by the same person.
- · Until the end of the current month, the only possible month to be specified in the application as the basis for calculation of the subsidy amount is March.
- · On the basis of the data entered, the application automatically calculates the maximum amount of the financial subsidy you are applying for
- You may interrupt the application process at any time and save the draft application. You don't have to finish the process in one session, you may enter data for the calculation and decide when you will send the application to the Polish Development Fund (PFR).
- Filling in the application on the Bank's website and concluding with its intermediation the Financial Subsidy Agreement will be the grounds for company's qualification for Tarcza Finansowa PFR (financial shield) programme.
- The application cannot be filed in a Bank outlet or at the info line.
- In case of rejection or if a different amount is awarded, you may file your appeal in Millenet for Companies in the Documents and applications (Dokumenty i wnioski) bookmark.
- · The process of applying for and deciding on awarding subsidies shall be carried out in four steps.



### lack HOW TO PREPARE FOR APPLYING FOR THE SUBSIDY UNDER TARCZA FINANSOWA PFR?

- Make sure that the data of your company (Name, NIP, REGON, date of establishment) in the Bank are up to date and consistent with the entry in the relevant register:
- · Make sure you are empowered or authorized (as an attorney) to represent the company in one person, also to conclude the Financial Subsid Agreement.
- Make sure that you have active access to online banking (MilleKod, login, password) and you have bank authorisation tools.
- Check whether your company conducted activity as of 31 December 2019.
- Prepare the financial data of your company, in particular the level of business turnover in selected months and number of persons employed in full time equivalents (including persons working under Civil Law contracts).
- · Make sure you are not in arrears with your taxes and social insurance contributions as at 31 December 2019 or as at the day of filing your application.


## HOW TO APPLY FOR THE SUBSIDY IN TARCZA FINANSOWA PROGRAMME?

Applications are filed in the online banking system Millenet for Companies. You will find the e-application in bookmark Dokumenty i wnioski (Documents and applications). After sending the application, you can check its status which within two days from sending should change from "Processed" to "Delivered". Therefore, we recommend monitoring the status in Millenet for Companies.

## ► HOW TO FILL OUT THE SUBSIDY APPLICATION?

Log to the online banking system Millenet for Companies in bookmark Documents and applications/Dokumenty i wnioski in section Financial Shield




Open the list and select the company, for which you want to apply for subsidy.

#### What you should know

 The screen below is only for companies with Shared MilleKod/MilleKod Wspólny (a few companies on one MK) and allows to select one of the companies for which you want to apply for subsidy.




Upon selecting the company the Programme information will be displayed – review it. Company's data are filled in automatically – check if they are correct. In the last field enter PKD code of the company for which you want to apply for the subsidy.



Select type of enterprise under which your company can be classified.

#### What you should know

• Verify the stated values against the data of your company as of 31.12.2019. Define the number of the employees by the working hours (FTEs) and only those employed on a contract of employment. To determine the value of the annual turnover and total assets use the average NBP FX rate for EUR as at 31.12.2019, i.e. 4,2585.



When you open the list select the account, which you want to be credited with the subsidy.




Define whether the business of your company is seasonal (in case of Microenterprises).

Additionally:

In the field "Number of employees at the end of the previous month" indicate the number of employees as at the end of the previous month. In the field "Number of employees on 31.12.2019" indicate the number of employees as at the end of 31.12.2019.

If your company is from the Small and Medium-sized Enterprises sector, the question about seasonality of the business is not applicable. Indicate the number of employees as at the end of the previous month.



#### What you should know

• You define the number of employees by the working hours (FTEs) for those employed on a contract of employment and adding to this number the number of cooperating employees whom you reported to ZUS (you count each such employee as I).

Note – the data entered will be verified by PFR against the data of the Social Insurance Institution (Zakład Ubezpieczeń Społecznych).


In section Your company's financial information/Informacje finansowe Twojej firmy:

Indicate trade turnover of your company in the entire 2019.

#### Select the form of counting decrease in turnover from:

a. y/y - for a selected month when the turnover decreased, then the corresponding month of the previous year will be considered, or b. m/m - for a selected month when the turnover decreased, then the month preceding this period will be considered.

Select the reference month (month when the turnover decreased), which you want to consider as the month with decreased turnover.




State turnover in the selected declining month and additionally, depending on the selected form of counting the decrease in turnover, state:

- a. for the m/m method turnover in the month preceding the reference month (month with decrease in turnover),
- b. for the y/y method turnover in the month of 2019 similar to the reference month (month with decrease in turnover).

Note – the data entered will be verified by PFR against the data of the National Revenue Administration (Krajowa Administracja Skarbowa).


Upon stating the above data, range of decrease in turnover and Maximum amount of financial subsidy will be displayed.

In the field Financial subsidy amount you are applying for enter the value of the subsidy applied for, however, not higher than that indicated in the field Maximum amount of financial subsidy.







If you receive a negative decision, you can submit your application again. Remember to clarify in advance the reasons behind the rejection of the application and check the correctness of the data.
